### CANOEING AT W.W.K.C.

**Summer Season (1 May to 15 September):-** Groups of 3 or more beginners of ICU Level II Proficiency may paddle unsupervised above Palmerstown Weir. Such groups must be accompanied by a more experienced paddler if they wish to shoot the Weir.

**Winter Season (16 September to 30 April):-** Groups of 3 or more paddlers of ICU Level III Proficiency may paddle unsupervised above Palmerstown Weir. They can have paddlers of Level II Proficiency with them. These groups must be accompanied by a more experienced paddler if they wish to shoot the Weir.
